General Information:

The Luminator LED Quad Light is equipped with an internal flasher with 29 selectable flash patterns including random.

Changing Flash Pattern:

To change flash patterns, press and hold the mode switch for less than 5 seconds. To reset to factory default pattern, press and hold the mode switch for more than 5 seconds.

Installation Instructions

1a. Luminator LED Quad Light Installation With Bracket

Drill out the mounting hole, Point A, on each end of the Luminator LED Quad Light to 11/ 64".

Attach the bracket to desired location using the (2) longer screws.

Then place the Quad Light into the bracket and attach it using the shorter screws and locknuts. Plug adaptor plug into accessory outlet.

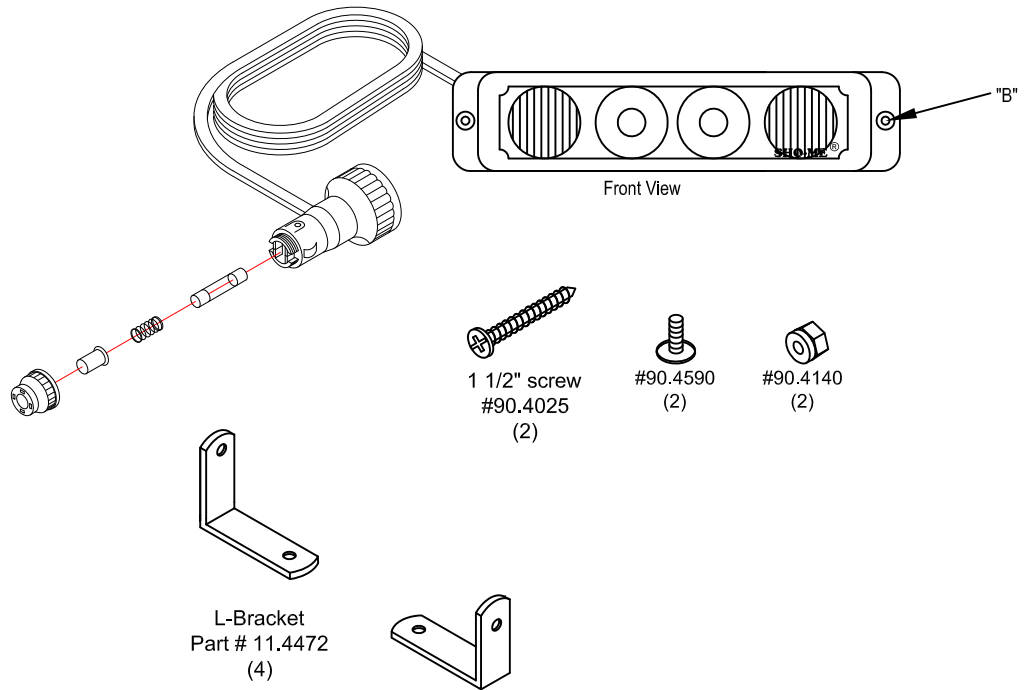
1b. Luminator LED Quad Light Installation Without Bracket

Use Point B. Drill the 2 holes on the mounting surface for the Luminator LED Quad Light using the Quad Light as a guide. Attach the Quad Light using (2) longer screws provided.

2. The Lighter plug adaptor has an on/off power switch and a momentary mode switch to select the desired flash pattern.
