

INSTALLATION:

Mounting:

Mount the bracket to the vehicle in the desired location using the screws provided. Attach The Microthin to the bracket using the two 7/16" bolts and lock-washers provided.

The Microthin can be mounted to a horizontal or vertical surface and can be aimed on many directions. Do not mount the Microthin with the **lens** pointing straight up as this may cause the lens to overheat.








Connect to Power Supply:

Route the cable through the vehicle body and plug into the Strobe Power Supply.


The shield wire may also be connected to

chassis ground to reduce RFI.



FLASHTUBE REPLACEMENT:

REPLACEMENT TUBE PART #: 20.1880
Remove the two screws which hold the lens to the body of the strobe head. Remove the lens and pull out the flashtube/reflector assembly. Disconnect the flashtube/reflector from the two connectors on the cable and plug in the new one. Re-assembly is the reverse of the above.
